Due to the four uncontested races, the Certification Letter confirms it is appropriate for the following named Councilpersons are to be officially sworn into office on the 1st day of May 2023.


Pursuant to 15 Del. C. §7558(d) and given incumbents:


Daniel Marabello – Ward One

Jason James - Ward Four


These candidates are entitled to assume office without a formal election pursuant to 15 Del. C. §7555(j).
